

Contest Rules :

RULES RELATED TO THE GAGS AMATEUR CONTEST – JUST FOR LAUGHS, INC.

1. Participants can enter by submitting a video containing an original hidden camera Gag not more than 3 minutes in length, via the registration page - <http://www.justforlaughs.ca/contests/enter/1>. All entries and videos become the property of *Justepourrire.com inc*
2. The submitted entry must not be a copy, an adaptation or a translation, total or in part, of any texts or concept written or created by another person and used without his/her content. Participants solemnly declares to Justepourrire.com that the video submitted is an original creation, will not violate any copyrights, nor constitute grounds for any libel or defamatory action, and does not invade the privacy or compromise the reputation of any person. Participant will hold harmless, and indemnify, *Justepourrire.com* against all damages that may result from actions covered by the aforementioned warranties.
3. Each participant, as the author of the video submitted to this contest, authorises JustePourRire.com to :
 - Commercialize the videos, non exclusively, for the duration of the author's rights, as determined by law, present of futur, worldwide.
 - Technically modify, prior to posting online, all files submitted by the participant, notably for the purpose of format conversion and compression, as well as for any other purpose related to the exercise of the rights hereby conceded. Rights conceded include :
 - Reproduction rights : right to reproduce, without limitation, any or all parts of the videos, on any optical, numerical, paper, disk, network, floppy disk, electronic, DVD, CD, CDI, CD-ROM, Internet, Extranet, I-mode, Wap system, device or media, as well as any other media and support system not listed but applicable, for the purpose of incorporating them into other services or offers, electronic or audio-visual.
 - Adaptation rights : The right to adapt any or all parts of the videos, on all media covered in this article and any other media in existence or to be created; as well as the right to edit and incorporate any and all parts of the videos into other artistic or commercial creations, in existence or to be created. Adaptation rights include the right to translate or modify the videos in part or in their entirety, in any language, as well as the right to reproduce translated versions on any media covered in this article
 - Representation rights : the right to broadcast and otherwise showcase, project, display, deliver or stream, without limitations, any and all parts of the videos via all media and communication systems, in existence or to be created, including the Internet, Intranet, Extranet and other IP-based networks, as well as cable or satellite, directly or with the help of third party system providers.
 - Distribution rights : The right to commercialize, for free or for money, including through rental and club memberships, any videos and their adaptations, on all media, in existence or to be created, at any location, for any public, without limitations; as well as the right to concede to any third party, any and all parts, in any form possible, be it via sub-licensing, sales agreement or other, any and all rights, temporarily or in perpetuity.

- Concession rights : the right to concede all rights to third parties, of any and all parts of the videos, via any formal agreement possible, notably a license, temporarily or in perpetuity

The aforementioned copyrights transfert and formal cession is executed without any financial or other types of compensation. JustePourRire.com agrees to mention the identity of the participant and the title of the video, whenever possible.

4. The editorial team of JustForLaughs.com or its representatives will select among all entries a handful of videos to submit to a vote by the membership of the site. This selection will take place from time to time, for as long as the contest is in effect, without prior notification to the participants whose videos were selected

5. The participant whose video will have been selected as the preferred one by site members who voted during a voting session will receive \$500 or two tickets to attend one of the Galas taking place during the 2007 Just For Laughs Festival, as determined by the editorial team. This prize represents the entire prize to be shared among all authors of the videos identified in the entry form. The video itself will be labelled « finalist/amateur contest » on the site.

6. At its discretion, JustePourRire.com may organize a round of voting involving only finalists to determine the preferred video among those. The participant whose video will have been deemed the preferred one among finalists by site members during a voting session will receive ***an invitation to join the Gags filming crew, as co-director, for a day, and participate in the shooting of a Gag.*** The prize will be accepted *as is* and cannot be modified or transferred. No substitution will be offered or accepted. Declining the prize will result in complete discharge of any and all responsibilities of *Justepourrire.com inc* towards the participant or the delivery of a prize.

7. Decisions by the editorial team of JustePourRire.com are final and cannot be appealed.

8. The contest is open to all members of the site JustForLaughs.com. The participant who submitted the preferred video agrees to allow *JustePourRire.com* to use his/her picture for promotional purposes, as a condition of obtaining his/her prize, without any expectations of compensation other than the prize itself.

9. All entries are subject to verification. Any incomplete or fraudulent entries will be automatically eliminated and disqualified from participation in the amateur contest. The winners will need to agree to sign a written document confirming their eligibility to participate.
